Underwriting capital is provided by ProAssurance Corporation (rated "A+" (Superior) by A.M. Best), Private Names and Third Party Corporate Providers.

Property Reinsurance

The team writes a portfolio of Property and Short Tail Specialty reinsurance.

Property

We write a book of property per risk and catastrophe reinsurance, operating on a worldwide basis but with a specific focus on business emanating from the US, Canada, Europe, Japan and Australasia complemented by a portfolio of business from what can be considered more emerging insurance environments.

Business is priced using a combination of vendor model and Syndicate-devised bespoke pricing techniques. As we build a portfolio particular focus is directed at how additions and reductions to the current portfolio have an impact on the Syndicate's overall risk metric dynamics.

We underwrite a book of North American Crop Reinsurance comprising reinsurance of Multi Peril Crop Insurance (MPCI) and Crop Hail exposures in the US and Canada. We have the ability to quote and structure such placements and will seek to lead business where this makes commercial sense with our limited line size at this time.

Terrorism

This account is predominantly excess of loss reinsurance of certain Lloyd's Syndicates and Companies who have shown discipline in navigating this complex class as evidenced by top tier exposure management systems and strong underwriting discipline and results.
